**Dr. S. Jaishankar** Foreign Secretary of India

Dr. Jaishankar has more than three decades of diplomatic experience. Joining the Indian Foreign Service in 1977, Dr. Jaishankar has represented India's interests and fostered friendly working relationships in countries around the world.

Dr. Jaishankar's first postings abroad were as Third and Second Secretary (Political) at the Embassy of India in Moscow from 1979 to 1981. From 1981 to 1985, he served as Under Secretary (Americas) and Policy Planning in the Ministry of External Affairs. He then spent three years from 1985 to 1988 as First Secretary handling political affairs at the Indian Embassy in Washington, DC, followed by two years as First Secretary and Political Advisor to the Indian Peace Keeping Force (IPKF) in Sri Lanka.

In 1990, Dr. Jaishankar became Commercial Counsellor in Budapest. After three years in that position, he returned to India where he served first as Director of East Europe Division of the Ministry of External Affairs, and then as Press Secretary for the President of India. Following this service in India, Dr. Jaishankar went abroad again - to Tokyo in 1996 as Deputy Chief of Mission. In the year 2000, he was appointed the Ambassador of India to Czech Republic and served in Prague till 2004.

Upon completing his time as Ambassador in Prague, Dr. Jaishankar returned once again to India, where he led the Americas Division in the Ministry of External Affairs. After three years heading the division, he again left India in 2007 to serve as High Commissioner to Singapore for two years. Dr. Jaishankar was the Ambassador of India to China from 2009 to 2013 and was the Ambassador of India to US before assuming responsibilities as Foreign Secretary.

	Dr. Jaishankar holds a Ph.D. and M.Phil in International Relations and a M.A. in Political Science. He is a member of the International Institute for Strategic Studies in London. Dr. Jaishankar is married to Kyoko Jaishankar and has two sons and a daughter.

Ambassador Yoshiji Nogami President and Director General, Japan Institute of International Affairs Amb.Yoshiji Nogami is President and Director General of the Japan Institute of International Affairs (JIIA) and Executive Advisor to Mizuho Bank, Limited. From 2004 to 2008, he was Japanese Ambassador to the UK. After graduating from the University of Tokyo in 1966, he joined the Ministry of Foreign Affairs, where he served as Deputy Director-General of the Middle Eastern and African Affairs Bureau and the Foreign Policy Bureau, Director-General of the Economic Affairs Bureau, Deputy Minister for Foreign Affairs, and Vice- Minister for Foreign Affairs of Japan. His overseas posts include Economic Counsellor at the Embassy of Japan in the US, Consul-General in Hong Kong and Ambassador to the OECD in Paris. He was a Senior Visiting Fellow at the Royal Institute of International Affairs.

He has been India's longest serving Ambassador to Japan (2006-2010), Ambassador to Indonesia and Timor Leste (2003-2006), Ambassador to Colombia, Ecuador and Costa Rica (1999-2002), and India's Deputy Permanent Representative to the UN in Geneva (1995-1999). He has held several significant assignments during his career, dealing with the United States, West Europe and the European Union and India's immediate neighbours.
Ambassador Singh has contributed to the forging of the India- Japan strategic and global partnership, the intensification of India's relations with Indonesia and ASEAN, the evolution of India's revitalised Look East Policy and the shaping of India's policy towards key neighbours and strategic partners.
From 2011-2016, Ambassador Singh was Professor for Strategic Studies at ICRIER, a leading think tank in New Delhi, and has been associated with several public policy initiatives and Track II / Track 1.5 strategic dialogues involving major Think Tanks of India, Japan, Asia and the US. He has written and worked extensively on the ongoing transformation of India's relations with the United States and Japan and their growing convergences in shaping Asia's emerging economic and security architecture. He serves on statutory and advisory corporate boards and has been Senior Advisor at Dua Consulting since 2013.
In June 2016, Ambassador Singh assumed responsibilities as Director General, Delhi Policy Group, which is among India's oldest independent think tanks focused on strategic issues of critical national interest.
An alumnus of St. Stephen's College, Delhi, where he studied (1967-72) and later taught (1972-74), Ambassador Singh holds an M.A. degree from the University of Delhi. His varied interests include civilisation and culture, the natural environment and sports.

Dr. Seiichiro Takagi is senior research advisor of the Japan Institute of International Affairs (JIIA). He obtained Ph.D. in political science from Stanford University in 1977. Before moving to his current position in April 2011, he was associate professor and professor at Saitama University (1979-97). professor at National Graduate Institute for Policy Studies (1997-99), Director of the Second Research Department at The National Institute for Defense Studies (1999-2003), and professor at the School of International Politics, Economics, and Business, The Aoyama Gakuin University (2003-2011). He is a specialist on Chinese foreign relations and security issues in the Asia-Pacific region. He is a member of the Japan Committee of the Council for Security Cooperation in the Asia-Pacific (CSCAP), President of Japan Association for International Security Study, a board member of the Kazankai, incorporated foundation devoted to academic and cultural exchange with China and other Asian nations, and a member of governing council of the Research Institute for Peace and Security.

#### Noriyuki Shikata

Deputy Director-General, Asian and Oceanian Affairs Bureau, Ministry of Foreign Affairs of Japan

Mr. Noriyuki Shikata is Deputy Director-General, Asian and Oceanian Affairs Bureau, Ministry of Foreign Affairs of Japan. After graduating from Faculty of Law, Kyoto University, he entered the Ministry of Foreign Affairs (MOFA) in 1986. He was Director, Personnel Division, Minister's Secretariat (2014-16), Political Minister, Embassy of Japan in the UK (2012-14), Assistant Cabinet Secretary for Public Affairs/Director of Global Communications, Prime Minister's Office (2010-12), Director, Economic Treaties Division, International Legal Affairs Bureau (2009-10), Director,

	Second North America Division(Economic Affairs), North American Affairs Bureau (2007-09), Director, Status of U.S. Forces Agreement Division, North American Affairs Bureau (2004-06) and Assistant Press Secretary/Director, International Press Division (2006-07). He is also Visiting Professor, Graduate School of Law/ Public Policy, Kyoto University from April 2016. He obtained Master in Public Policy from Kennedy School of Government, Harvard University in 1989.

Ambassador Biren Nanda Senior Fellow, Delhi Policy Group Ambassador Biren Nanda served in the Indian Foreign Service from 1978 to 2015 and is a distinguished former career diplomat with extensive experience of working in East Asia. He has been India's High Commissioner to Australia (2012- 2015); Ambassador to Indonesia, Timor Leste and the ASEAN (2008-12); India's Deputy Chief of Mission in Tokyo (2000- 2004) and Consul General in Shanghai (1996-2000). Ambassador Nanda has also served in Indian Missions in Beijing, Washington DC and Singapore. He spent a total of ten years in China during his three terms as a diplomat in that country. His entire career as a diplomat was spent in East Asia with the sole exception of his Washington posting. During 2004-2008 Ambassador Nanda was posted in the Ministry of External Afairs in New Delhi as Joint Secretary (South) and was responsible for India's relations with Southeast Asia and the Pacific. Ambassador Nanda contributed to the strengthening of the strategic partnership between India and Indonesia, the strengthening and diversification of India's relations with Australia and helped reinvigorate India's Look East Policy and the intensification of India's ties with ASEAN and Pacific countries.

Gill Joint Secretary (DISA), Ministry of External Affairs Mr. Amandeep Gill joined the Indian Foreign Service in 1992 and is currently Joint Secretary and Head of the Disarmament & International Security Affairs (D&ISA) Division at the Ministry of External Affairs in New Delhi. His responsibilities include all current issues of disarmament, nonproliferation and arms control relevance as well as bilateral negotiations on civil nuclear cooperation and strategic trade.
	Previously, Mr. Amandeep Gill has served abroad at the Indian Mission to the Conference on Disarmament in Geneva, the Indian Embassy in Tehran, the High Commission of India in Colombo and the Indian Mission to the UN in Geneva. At headquarters in New Delhi, he has served twice in the Disarmament and International Security Affairs Division (in addition to his current assignment) as well as in the United Nations Division. He has also served as an expert on the UN Secretary General's panels of experts on the Fissile Material

	Cut-off Treaty (FMCT), Small Arms and Light Weapons and on Missiles. He participated in the UN Disarmament Fellowship programme in 1999. Mr. Amandeep Gill has a B Tech in engineering from Punjab University, Chandigarh and an Advanced Diploma in French History and Language from Geneva University. During 2008- 2009, he was a visiting scholar at Stanford University's Center for International Security and Cooperation (CISAC) on an Asia Foundation regional security studies fellowship. He is enrolled since 2012 as a PhD candidate, at the Department of War Studies in King's college, London; his research topic is nuclear learning. As a scholar he has contributed to the Bulletin of Atomic Scientists, the Lowy Institute, the East West Institute, the Center for a New American Security and the Indian Economic and Social History Review. He is married to Ashma Singh and has a daughter (Bani) and a son (Ujjay). His personal interests include creative writing, yoga and sustainable agriculture.

	From 2004 to 2007, Mr. Jha served at the Ministry of External Affairs in New Delhi on the Americas Desk. During this period, he was involved with India-US nuclear negotiations and also handled issues pertaining to Space, Defence, and High Technology cooperation with the USA.
	From 2007 to 2010, he was posted to Colombo as Counsellor in-charge of Economic, Commercial and Developmental issues. He was a member of the Indian delegation for negotiation of the Comprehensive Economic Partnership Agreement (CEPA) with Sri Lanka. After the end of civil conflict in Sri Lanka in 2009, he was also involved with developing the architecture of development aid from India to Sri Lanka.
